

## **Certification**



#### Get Certified with the Help of Your Local Chapter!!

For fifteen years the Volusia/Flagler SHRM chapter has offered HR Certification exam preparation courses to our members. We have had some significant interest over the tenure of this program. The last few years, there have been around 5-7 members taking this course each year. Each module was taught by certified volunteers from our chapter. We see this as a critical component to every HR professional and we want to enhance this program. As a result, we want to elevate this program and we are partnering with the University of Central Florida. If you were able to make the February meeting, you saw an introduction of this great partnership. We will be sharing more information with you as the classes approach. There will be two offering during the year (Spring and Fall).

Below is what we'll be able to offer with this new program.

- \$929.00 is the UCF / SHRM Member rate to our members. When registering, you may select the SHRM rate or you may call the UCF offices and they can help with registration.
- The courses provide a foundation in HR including the <u>online</u> HR Essentials and HR Generalist Certificate courses, the PHR/SPHR certification preparation course as well as more advanced topics such as the Global HR Professional (GPHR) and online courses that provide recertification credits. There may be some of you who are not quite ready for the PHR/SPHR certifications and others that have already achieved these and want to take the next steps in the field.
- Regarding the price point of the program: UCF would like to ensure that each of the participants knows the amount of printed materials, online materials, classroom time and support that comes with the registration fee. Each participant receives:
  - o Thirteen instructor led sessions including a bonus review session at the end of the program.
  - o Facilitators are selected for their expertise in their subject areas and are SPHR-certified or legal experts.
  - o Live sessions allow participants to not only network and learn from the instructors, but also with their peers and can share experiences.
  - o The 2014 SHRM Learning System (Materials alone are priced between \$695 \$860.00 if ordered directly from SHRM) which includes a book for each of the six modules, an SPHR study book and a printed final exam.
  - The 2014 SHRM Learning System Online materials which include a pre-test to gauge initial knowledge, two tests for each
    module, a final post-test, electronic and printable flashcards, online resource center, bonus tests, case studies, glossary
    and more.
  - o The printed module books can also be downloaded to be accessed from an e-reader device.
  - A binder of materials from UCF including PowerPoints to follow along in each session, reinforcement activities to practice what has been learned, and additional certification details and information.
- The UCF staff often works with individuals to help them with their registrations and payments as well. UCF offers payment plans so that participants can pay in installments leading up to the course, spreading the cost over a few months rather than paying in one lump sum. These payment plans are available on the course web pages at <a href="www.ce.ucf.edu/phrm">www.ce.ucf.edu/phrm</a>. If participants are Veterans, they often work with the VA to sponsor training and will direct participants who are unemployed to possibly receive funding through their local workforce board. Many participants also use tuition reimbursement and they are familiar with many typical company guidelines and can present necessary certificates, grades, receipts, etc. for those participants.



The Chapter had another great year and I want to say thank you to everyone for making it such a success. Some highlights are below.

- As of December 2013, our Chapter had 125 members and for the second straight year has received the designation from National SHRM as a Membership Superstar, because our annual membership increased over 4%.
- The Chapter partnered with the Center for Business Excellence on their annual Summit, where our Chapter conducted an HR Track on Health Care Reform to over 150 attendees.
